# The Case for Disqualifying Donald Trump

# **Dear Mr. President:**

Vested in your office as Commander in Chief and with your sworn oath to protect and defend the **Constitution**, you have the power, authority, and duty to uphold the laws and statutes of the United States. You are the guarantor of free and fair elections. As you have observed, the election of 2024 **was not fair!** Only a week after the election, it's evident that **Trump** enlisted **Russian help with Putin and Elon Musk** to rig the election with AI technology. All are guilty of election interference and massive disinformation. Long accepted rules of fairness, of protocol, and of ethical behavior, must be rigorously applied to applicants for the highest office in our country. Infractions and violations of the law may not be tolerated! Allow me to outline several infractions.

Mr. Donald Trump must be disqualified for multiple infractions of standing laws, etiquette, fairness, justice, and honesty. Were he a Nobel Prize Lauriate, a high-standing representative of our government, for example an ambassador or senator, or if he were a victorious general decorated for achievements in peace or war, some infractions to the rules of fair play might be tolerated. **Mr. Trump is none of these.** As president, he was **twice impeached by Congress.** He faces so many legal suits, both civil and criminal, that he will have no time to serve as president. He will be sentenced on 26 November on 34 counts of felony. High officials and the supreme courts of several states have judged Mr. Trump to be an **insurrectionist**, who developed a vicious plot involving several states and a gang of co-conspirators to overthrow the government of the United States of American. His lies and rhetoric whipped a crowd of 50,000 armed insurgents into attacking the Capitol of the United States, while both houses of were in session certifying the

votes of the 2020 election. He lied to the insurgents that the country was in perilous danger. Many people were injured, some killed or died during and after the unprovoked onslaught. Mr. Trump is a **convicted rapist**. He is guilty of **massive fraud** in the state of New York and has been fined and must pay \$450 million. He **tampered with the election results** in Georgia and Arizona, where he awaits trial. In Florida he is accused, under the **Espionage Act, of stealing top secret government documents and hiding them from the government**. Despite all of this, you and the Biden-Harris government have generously allowed Mr. Trump to pursue his goal of being re-elected to the presidency.

Yet, in spite of your exceptional generosity, which the Biden-Harris administration granted to Mr. Trump to campaign for that office, he misused that trust at his rallies to verbally run the country down and lie about its good economy and good standing in the world. He did intimidate, threaten, con, and corrupt the electorate to the point that a majority has been duped, deceived, hoodwinked, inveigled, bamboozled, and misled to believe, that he is suited to be president and commander in chief. The voters have been cheated with the help of Elon Musk and AI to create mass psychosis (more on this soon).

Dear President Biden, the path to the White House must be through free and <u>fair elections</u>. Gangster methods employed by neighborhood thugs using death threats, brass knuckles, intimidation, legal tricks, corruption and cash payments to buy votes, may never be the path to our country's highest office. Yet, all this is *modus operandi* of Mr. Trump.

## In short, Mr. Trump has conducted an unfair election. He must be disqualified!

### Elon Musk's Massive Disinformation and mass psychosis using X

The technology entrepreneur and U.S. government contractor, Mr. Elon Musk, engaged himself to enhance his own fortune as *Mr. Trump's manager of disinformation*. Using the social media platform X (formerly twitter), he flooded the marketplace with false allegations, lies, and disinformation designed to confuse and mislead American voters. Musk's actions to manipulate millions of voters is highly unfair as his salacious and slinky allegations were designed to cover harmful, hateful, illegal, and intimidating acts of Mr. Trump.

Mr. Musk maintains, that "Who controls the meme, controls the world." A meme is an Algenerated image. Football is an all-American sport. The rules are well known. When a ball carrier steps out of bounds, the play is over and the ball is set at the point where the ball was carried out of bounds. A ball carrier may not leave the field, disappear under the bleachers, only to reappear at the goal to score six points. # 2024 election - not fair: Disinformation, intimidation, corruption, lies

Voters have been intentionally confused and misled and by Mr. Trump's barrage of bombastic lies and unsustainable assertions. His violent, dramatics serve to entertain and are full of primitive insults designed to appeal to elements of the electorate which enjoys brutality, savage cruelty and sadism. It is unfortunate that sensationalist politicians or populists, like Mr. Trump, capitalize on followers of that ilk. Mr. Trump promised unrealistic solutions to social issues as he manipulated the population to its own detriment, just as any con-artist cheats a customer out of his money only to disappear after the transaction. Mr. Trump creates non-existing social issues to draw attention to himself as if he could solve that non-existing problem.

**Lost Debate**: Mr. Trump hopelessly lost the first debate to V.P. Harris. He claimed that "immigrants in Springfield, Ohio, were eating the pets of Springfield's inhabitants." Nothing was true. He lied throughout the debate. Afterwards he claimed to the public that he had "won the debate." Mr. Trump intentionally caused civil disorder at Springfield and cast a dangerous xenophobic shadow over the Haitian inhabitants who had been invited to live and work there.

Knowing he had zero chance of outwitting V.P. Harris, he rejected a second debate in order to keep from the public his intellectual inferiority.

**No medical records:** Although V.P. Harris produced her medical records for public scrutiny, Mr. Trump declined to offer any certified details of his health or physical condition. This again is unfair and manipulates the public to support a 78-year old man, who may be at risk of soon dying.

After the Butler, Pennsylvania, assassination attempt and the wound to his ear, the attending hospital was forbidden to reveal any details of the dramatized minor injury.

**Traditional Election Highlight, CBS-News 60-Minutes Interview:** For decades the CBS Radio and TV Network has supported voters to better understand the personality, philosophy, viewpoints, and programs of politicians applying for the presidency. V.P. Harris willingly participated in the interview. Such top interviews are conducted by investigative journalists.

Mr. Trump declined to permit himself to be questioned, again demonstrating that he is hiding his lack of intellectual capacity and ideas for managing the economy or the presidency. Weeks later, it occurred to Mr. Trump that he might diminish V.P. Harris' outstanding performance during the interview by falsely claiming that the interview had been edited to her advantage. Having been too cowardly to participate in the interview, Mr. Trump had no right to criticize CBS's management.

**Violent, aggressive language:** Throughout his rallies, Mr. Trump consistently used profanity, immature and primitive name-calling, bullying, brutal, harsh, cruel, threatening, homicidal, and death threatening rhetoric to cover his lack of content and impress and confuse his audience. He maligned, slandered, and insulted - with the most primitive language, among others - the families of Pres. Joe Biden, V.P. Kamala Harris, Speaker Nancy Pelosi, Senator-elect Adam Schiff, and Rep. Liz Cheney. Mr. Trump's tools of leadership are fear, division, manipulation, revenge, and misinformation.

**Death-threats to opponents:** The Attorney General of Arizona is investigating a recent death-threat to a political opponent in the Republican party. Numerous death-threats to former U.S. generals, politicians, and journalists, who don't agree with him, are part and parcel of Mr. Trump's repertoire.

Loyalty to the United States: Mr. Trump has repeatedly stated that he cannot be loyal to the USA.

Generally speaking, Mr. Trump's behavior is unbecoming to the presidency, the White House and the highest office of our country. All of the above disqualify Mr. Trump from the presidency.

### **Four-star Generals disqualify Trump**

Four-star general Marc Milley, selected by Mr. Trump, served with Mr. Trump in the White House for four years. Milley coordinated communications with the Army, Navy, Airforce, and Coast Guard. Gen. Milley is quoted as saying, "Trump is unqualified to be president. Trump is the most dangerous man in the world for the USA, a fascist to the core." (Bob Woodward's book, "War", page 173-5. Printed 2024). Milley was joined by 4-Star General James Mattis, former Secretary of

Defense and Marine 4-star General John Kelly, former Chief of Staff in the White House. All agree that Mr. Trump is unfit for the presidency and is a dangerous man for the country.

**700 Top U.S. Officials stand against Trump:** Please also consider that a letter has been signed by 700 top security officials in support of Kamala Harris for president. Among those were generals from the Army, Navy, Airforce, Homeland Security, and National Guard representatives.

Trump's latest expressions of admiration for Putin, the long-time recognized enemy of the USA, must again be met with Trump's disqualification from the office of President. During his remarks in Atlanta, Georgia, on August 3rd, Mr. Trump once again, issued his shocking endorsement of "Vladi" Putin. Not the first time, that Trump has flaunted his admiration for Putin and other dictators and enemies of the U.S. Without provocation, the convicted war criminal, Putin, invaded the free country of Ukraine in 2022 and has caused immeasurable human suffering, destruction, and chaos to its population. Putin has threatened members of the NATO alliance with nuclear weapons and war.

National Security and Ukraine The U.S. has supported Ukraine with over \$130 billion. Supporting Ukraine is, for a multitude of reasons, in our country's best national interest. Over fifty nations from around the world have joined the U.S. to support Ukraine against Putin's malicious and unprovoked murder and destruction. Vice President – elect JD Vance said, "Ukraine and our support there means nothing to me."

When an American leader aligns himself with the likes of Putin and against the long-time declared enemies of the USA, they act against the U.S. Constitution in that they "provide support, aid and comfort to the enemy". It is self-evident that such treason may not be permitted to take the oath of office to the presidency.

If Trump's multitude of crimes against the people of the U.S. do not disqualify him for public office, his outspoken inclination toward our country's declared enemies must disqualify him.

### **National Security and Trump - Putin Collusion**

Throughout the campaign Trump prided himself on his good relations with Russia's Putin. He boasted that he could end the war in Ukraine in one day, which impressed his supporters. On 10 November this week, Trump claimed that he had spoken with Putin insisting that he stop the war on Ukraine. Trump's demand flaunted his relationship with Putin.

Putin's response was designed to put Trump down and demonstrate that Putin now had the U.S. president in *his pocket*. His abuses of Trump opened with nude pictures of Trump's wife on Russian TV. Putin claimed that Trump was lying: There had been no call regarding the war in Ukraine. Putin is said to be amassing 50,000 troops (10,000 N. Koreans) ready to invade Ukraine and that he wants all Ukraine. Putin shows no respect for Trump or the USA, which elected him. Breaking News of 12 November featured Russian spy chief, Nikolay Patrushev, reminding Mr. Trump that Russia had supported Trump's election with "certain forces" and expected to be compensated for services rendered, soon.

# Once again, Mr. Trump is caught toying with treason.

# **Disrespect for Military Sacrifice and Traditions**

Trump's embarrassing neglect of rules governing the sanctity of Arlington National Cemetery and the military heroes laid to rest there, is one further measure of his disrespect for the price generations of Americans have paid for freedom and the values, which our country holds dear. Please see this:

To be president, a person must swear to protect the U.S. Constitution. Trump broke that oath already once. He should never be given another chance and cannot be trusted with national secrets.

A fair election, it was not! Mr. Trump used his rallies to disinformed the public, trashing the state of the USA. While Mr. Trump claimed that the country is in ruins and a banana republic, with rapists, murderers, drug gangs and angry immigrants brutalizing our streets, the opposite is true: In 2021, the Biden-Harris administration took over a desolate country ravaged by Covid, death, inflation, high unemployment and economic decline.
